PROCEEDINGS OF AYUSHMAN AROGYA MANDIR (AAM) MEETING chaired by Additional Chief Secretary and Development Commissioner, Government of Karnataka

Mission Director, NHM began with a brief overview of the Comprehensive Primary Health Care-Universal Health Coverage (CPHC-UHC) program.

The initiative, aligned with the National Health Policy 2017, was launched to transform the healthcare delivery system from selective to comprehensive care. This forms the core of Ayushman Arogya Mandirs (AAMs), aiming to integrate preventive, promotive, curative, and rehabilitative services. While the first AAM was launched nationally on April 14, 2018, Karnataka had already initiated transformation of Sub-Health Centres (SHCs) and Primary Health Centres (PHCs) into AAMs from FY 2016–17. Currently, 6532 AAMs have been operationalised against the target of 7045.

Key Discussion Points:

1. Review of JS, MoHFW D.O. Letter (Ref No: NHSRC/EDSectt/22-23/Visit report/0017):

The letter suggests reassessing the human resource deployment under AAMs and emphasizes the positioning of Community Health Officers (CHOs). It notes that the state should reassess its plan for reallocating human resources, specifically addressing the removal of the CHO positions at AAMs and establishing ANM-led AAMs.

2. Remarks by the Principal Secretary, Health & Family Welfare:

- o In light of MoHFW guidelines capping approvals to 125% of the resource envelope, Karnataka has rationalised its 2025–26 budget. Activities worth ₹256.09 crore were surrendered, and supplementary approvals of ₹193.52 crore were obtained.
- o The total approved budget, including Infrastructure Maintenance (IM) and Kind Grants, is ₹3,130.72 crore (123.94% of the resource envelope). Programmatic approvals (excluding IM and Kind Grants) amount to ₹2,672.45 crore.

- o As FY 2025-26 is the final year of NHM (2021-26), with increased Kind Grants and reduced Cash Grants, fiscal space is limited. Committed liabilities of approximately ₹322 crore must be met.
- Priority has been given to beneficiary-focused schemes such as JSY, JSSK., NIKSHAY, Family Welfare, PMNDP, diagnostic services, and salary payments to contractual staff.
- o There is need to provide career progression for the newly created CHO positions as otherwise they continue to be stagnant at the same position. The C&R Rules need to be amended to incorporate the position of CHO as continuing them on contractual basis is leading to legal as well as operational issues.
- B.Sc. Nursing graduates are being considered for upcoming Public Health Care
 Officer recruitment under revised Cadre & Recruitment (C&R) Rules.
- o In this regard, department has decided to temporarily reallocate the responsibilities of existing HR at sub-centres keeping in view the above issues as well as the vacancies in both ANMs and CHOs.

3. Observation by Principal Secretary, Finance Department:

The letter of MoHFW has highlighted an important issue of reallocation of CHOs across AAM and establishment of ANM led AAM by the State Health Department. FD does not support this redeployment and the report of BCG that has been reportedly used by the State Health Department is not the view of FD.

FD suggests to continue with the CHO-led AAM as this is the pattern across the country and has been working well in Karnataka for the last 8-10 years. FD would request HFW to prioritise strengthening and expanding CHO-led AAMs in the state through its resource envelope under NHM. It was also noted that both in FY 24-25 and FY 25-26 amount for recruitment of CHOs was surrendered in the resource envelope. This being an important intervention it should be retained and proposed for inclusion through the supplementary PIP process in the current year.

4. Concern Raised by the ACS & Development Commissioner:

It is not the case that the ANM can perform the functions assigned to the CHO. There is a substantial difference in the qualifications of ANM and CHO. While the ANM has undergone the ANM training course after PUC, the CHO qualification is B.Sc. (Nursing) after PUC and a further training of 6 months to be eligible for posting as CHO. Furthermore, a significant portion of the population remains underserved due to reasons such as travel distance and wage loss, apart from the needs of bedridden or elderly patients with reduced mobility. Keeping in view the needs of the state's aging population and the need to expand palliative care, it is necessary to have two health staff (one for field work and one for facility operations) in each AAM, as per the existing norms, including those catering to populations below 2,500 to ensure effective delivery of the 12 service packages. Hence recruitment of all remaining 1,000+ CHOs to be prioritised in order to provide CPHC through the AAM. Decision on reallocating CHOs should also be put on hold.

Key Decisions Taken:

- 5. Monitoring of AAMs to be enhanced and additional services should be rolled out.
- 6. Strengthening of Jan Arogya Samiti (JAS) to be prioritized.
- Recruitment of all remaining 1,000+ CHOs. File to be moved to Finance Department.
 This should be included in the supplementary PIP process and a request should also be sent to MoHFW.
- 8. The reallocation of human resources should be put on hold since the state is moving for recruitment of additional CHOs.
